U.S. National Academy of Sciences Meeting on Nuclear Safety 26-28 Nov. in Tokyo

The U.S. National Academy of Sciences committee conducting the study "Lessons Learned From the Fukushima Nuclear Accident for Improving Safety and Security of U.S. Nuclear Plants" will hold a meeting 26-28 Nov. 2012 in Tokyo, Japan.

The purpose of the meeting is to gather information for a report that can be used to improve nuclear plant safety and security in the United States. The meeting is not an investigation of the events that unfolded at Fukushima, and the committee will not provide advice to the Japanese government, nuclear regulators, or plant operators.

The committee will hear from the experts who have knowledge of the events surrounding the Fukushima incident, and it will engage in discussions with them to better understand what occurred at the nuclear plants following the earthquake and tsunami. The public and media are invited to attend the meeting. However, the meeting is not a public debate or a press conference. Video cameras will not be permitted in the plenary or breakout sessions. Neither the public nor the press will be allowed to provide verbal comments nor ask questions of the speakers or committee during these sessions.

The U.S. National Academy of Sciences is a private and independent nonprofit institution. It is not part of the United States federal government. It was formed in 1863 to provide objective science, technology, and health policy advice independent of the government.

The U.S. National Academy of Sciences enlists leading scientists, engineers, and other experts to answer the scientific and technical issues facing the United States. For each requested study, committee members are chosen for their expertise and experience. All nominated committee members undergo a conflict-of-interest examination. In addition, committee members serve as volunteers and are not paid for their committee service.
