# **Morning Session**

Having experienced a cascading disaster (earthquake in January and heavy rain in September in 2024) in the Noto Peninsula, Japan,

The morning session heard actual situations of the disaster from the Mayor of Anamizu Town, who also mentioned countermeasures for enhancing resilience of the town, preparedness, and expectations for S&T.

The members of the Committee on Cooperation of Academics for DRR explained the Advisory Opinion "Preparing for Wide-Area Regional Disasters Based on Lessons from the 2024 Noto Peninsula Earthquake and Heavy Rain Disaster," and discussed scientific aspects of the hazards, lessons learned in terms of disaster management, and countermeasures for the future, especially in local, isolated, rural, and underpopulated areas.

## **Afternoon Session**

Recognizing the importance of megacities, which make strong socioeconomic impacts to the world when they are affected by catastrophic hazards such as earthquake, tsunami, hurricane, and volcano eruption,

The IRDR Sub-Committee has drafted the recommendation document during a half year before the Forum.

Hearing a keynote speech on the New Urban Agenda (Quito Declaration),

The Forum Chair summarized contents of the recommendation document, and the authors of each chapter explained some more details of recommendation items.



## **Panel Discussion Session**

Based on the discussions in the Afternoon Session, and

IRDR representative's speech,

The members of the International Advisory Board (IAB) of ICoE-Coherence, which is an IRDR ICoE (International Center of Excellence) and composed of the 20 JHoP member organizations, gave their views on the recommendation document from their expertise.

The panel coordinator had a lively discussion among the panelists and summarized the panel discussion.

# Forum Chair Statement (1)

We are living in a vulnerable world.

We would like to transform the world to be sustainable to future generations with a safe, secure, peaceful, healthy, affluent and resilient society.

From this viewpoint, considering rapid global changes in climate and social environment, we especially discussed how to cope with catastrophic disasters in growing megacities, which are home to large populations and vast assets, but face extreme disaster risks, and often lack disaster preparedness and sufficient resilience.

# Forum Chair Statement (2)

Recognizing again the importance of global agendas such as the Sendai Framework for DRR 2015-2030, Sustainable Development Goals (SDGs), Paris Agreement for Climate Change and New Urban Agenda (Quito Declaration),

Recognizing also the importance of international cooperation research activities such as IRDR, which sets nine priorities for 2030 and beyond (<a href="https://www.irdrinternational.org/upload/20241211/a117c235ce8ad8.pdf">https://www.irdrinternational.org/upload/20241211/a117c235ce8ad8.pdf</a>),

We believe science, technology and innovation contribute to scientific-based, evidence-based and risk-informed decision and policy making towards sustainable future.

We strongly encourage all stakeholders—scientists, policymakers, and practitioners—to get together and contribute to this collective effort and turn these priorities into actionable solutions.
